MOTION

The Bomet County Supplementary Appropriation (No. 2); Bill, 2016

Hon. Speaker: The Vice Chair, Budget and Appropriation Committee. Yes honourable Langat.

Hon. R. Lang'at (Vice Chair, Budget and Appropriation Committee): Thank you Hon. Speaker. I wish to move the Budget and Appropriations Committee's Supplementary Appropriation bills, bill no.2. 2016. This bill is long overdue as we were supposed to dispense with it and ensure that reallocations of the money can be withdrawn. Hon. Speaker, this is a bill that seeks to give authority to the County Government to withdraw and use the money that was appropriated and I wish to urge the House that we allow this bill be read the second time. I request honourable Serbai to second.

Hon. R. Serbai: I Second!

Hon. Speaker: Thank you honourable Langat and Honourable Serbai. I now propose the question that the Bomet County Supplementary Appropriation No.2, Bills 2016 be read the second time. It is Open for debate. If there is nobody else then honorable Langat you can proceed.

Hon. R. Lang'at (Vice Chair, Budget, and Appropriation Committee): Thank you very much honourable Speaker. I know the members are in agreement with the second reading of the Bill and I know it's almost the end but none the less its one critical bill that is supposed to be passed and Mr. Speaker I thank all the members for accepting that this Bill be read the second time.
