Remember if we are not able to approve the Supplementary Budget then Members and members of staff in the executive will not be able to receive their salary. The development in this County will stall.

Therefore, I request that we persevere with the situation. Thank you.

#### **❖ PROCEDURAL MOTION**

**Hon. Speaker:** There is a procedural motion. This motion was supposed to be moved by the leader of majority but I will task the leader of minority to move the said motion.

**Hon J. Chepkwony**: Thank you very much Hon Speaker, I rise to move this motion that pursuant to Standing Order 231 the Bomet County Supplementary Appropriation Bill, Bills no. 2 of 2017 be exempted from Standing order no 121.

Standing Oder 231 is about exemption of business from Standing Orders Subject to paragraphs (2) and (3), a Motion may, with the approval of the Speaker, be moved by any Member, either with or without notice that the proceedings on any specified business be exempted from the provisions of Part VI (Sitting and Adjournments of the County Assembly), Part VIII (Order of Business), Part XVI (Limitation of Debate), Part XVIII (Public Bills), Part XIX (Private Bills), Part XX (Committee of the whole County Assembly) Part XXIII. (Supply and Ways and Means), Part XXI (Select Committees),

Part XXII (Public Petitions) and Part XXV (Public Access to the County Assembly and its Committees) of these Standing Orders:

Mr. Speaker the Standing Order no. 121 is on Publication which says No Bill shall be introduced unless such Bill together with the memorandum referred to in Standing Order 118 (*Memorandum of objects and reasons*), has been published in the County Gazette (as a Bill to be originated in the County Assembly), and unless, in the case of a County Revenue Fund Bill, an Appropriation Bill or a Supplementary Appropriation Bill, a period of seven days, and in the case of any other Bill a period of fourteen days, beginning in each case from the day of such publication, or such shorter period as the County Assembly may resolve with respect to the Bill, has ended.

That is why this standing order be exempted based on the standing order which validates exemption which is standing order no. 231. I beg Hon Samson to second this procedural motion.

Hon S. Towett: I stand to second the motion before us that this supplementary bill of 2016/2017 be exempted from the normal procedures based on standing order 231. And 121. The Bill before us is very important and it will ensure that the county will continue to finance its operations smoothly. At the moment we do not have sufficient funds, to finance the many activities in the executive and even in the county assembly. It is necessary to allow this bill to be exempted from the normal procedure so that we can approve it and allow the county government to access funds. We also do not have enough time to subject this document to the normal procedures provided for such bill thus the need to exempt it. This will allow the members to interact with their electorates as we seek a second term to represent them.

With the few remarks, I urge the colleagues to support this procedural motion, so as to enable us to go to the next stages. So as to make the bill become operational. Thank you
