THAT, aware that County transport including County roads is one of the functions devolved under Part 2 of the Fourth Schedule to the Constitution of Kenya 2010; also aware that in the 2017/2018 approved Medium Term Expenditure Framework, there is an allocation of a total of KES 446,156,244 for construction of roads, construction of bridges and installation of culverts; also aware that there are a number of uncompleted road projects throughout the County; further aware that Mengichik bridge in Singorwet Ward was indicated in the Monitoring and Evaluation Report as being 85% complete yet the social audit report of the same project indicates that the bridge is 20% complete; Deeply concerned that this bridge is vital as it connects Singorwet and Merigi wards and is being utilized by tea farmers and the business Community; this County Assembly urges the County executive committee once constituted to prioritize the completion of this bridge so as to assist the residents of Singorwet and Merigi wards.
