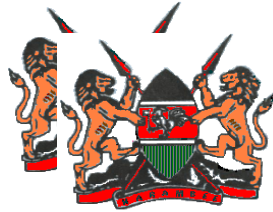

4. COMMITTEE OF THE WHOLE ASSEMBLY THE BOMET COUNTY SUPPORT FOR THE NEEDY (AMENDMENT) BILL, 2017(Bill N0.4

(Resumption of business interrupted on 28th December 2017 at 9.00 Am-Special Sitting)

The Speaker left the Chair and Hon. Weldon Kirui; the First Chairperson of Committees took the Chair;

Hon. Joseph Kellong, the Chairperson Committee on Education, Youth and Sports moved the following amendments;

- (a) **“THAT** Clause 2, be amended by deleting the Section 2 (a), “

The amendment was then proposed;

Debate arising;

- ii. Village elder;**
- iii. Youth representative;**
- iv. Person with Disability;**
- v. Women representative; and**
- vi. Representative of religious organizations**

“The Ward Bursary Fund Appraisal Committee members shall elect the Chairperson from amongst themselves”

The question was put and **agreed to.**

- (2) **THAT**, Clause 2 be renumbered accordingly

The question was then proposed;

Clause 1 was **agreed to**
