THAT WHEREAS Pursuant to Article 251(1) of the Constitution of Kenya and Section 58(5)(a) of the County Governments Act 2012, on the 17th of June 2014, this County Assembly approved a Motion to remove the Chairperson, Secretary and the Members of the Bomet County Public Service Board;

AND WHEREAS Pursuant Standing Order 64(6), the County Assembly approved a motion to establish a special committee comprising a third of the Members to investigate the proposed removal of the Chairperson, Secretary and Members of the Bomet County Public Service Board and to give effect to **Standing Order 65** of the County Assembly Standing Orders on the **right to be heard** and report to the County Assembly within ten (10) days of its appointment on whether it finds the particulars of the allegations against the Chairperson, Secretary and the members of the Bomet County Public Service Board to have been substantiated; this County Assembly Pursuant to Standing Order 64(6),(8),(9) and (10) resolves to adopt the first part of the report of the Special Committee on the proposed removal of the Chairperson, Secretary and
