### MOTION

#### ESTABLISHMENT OF A FUEL STATION AT LONGISA HOSPITAL

**Hon. Speaker (Hon. Cosmas Korir):** Hon. Members, the mover of the Motion Hon. Stephen Changmorik has requested to move the Motion today in the afternoon. Therefore, we can adjourn at this point.

**Hon. W. Kiprotich (Chepchas Ward, UDA):** Hon. Speaker, there was an answer to a question that was asked by Hon. Charles Langat. It was about the issue of waste disposal. It was committed to the Committee on Lands, Housing and Urban Planning. The Report was important to all the Members. I thought it was to be answered this morning. Further, there are stakeholders waiting for the answer.

**Hon. Speaker (Hon. Cosmas Korir):** Hon. Members, while we were in the order number seven, I expected the Chair to rise and answer but it seems he was not ready. Chair, what do you have to say?

**Hon. D. Busienei (Chemagel Ward, UDA):** Hon. Speaker, it is scheduled to be Tabled in the today's afternoon session. The report is ready. I had requested that we table in the afternoon session.

**Hon. Speaker (Hon. Cosmas Korir):** Hon. Kiprotich are you okay?

**Hon. W. Kiprotich (Chepchabas Ward, UDA):** Hon. Speaker. Obligated.

**Hon. Speaker (Hon. Cosmas Korir):** I urge all the Members to look at the pending Questions and Statements and complete before next week for us to move forward.

**Hon. D. Busienei (Chemagel Ward, UDA):** Hon. Speaker I had asked a question to committee on Agriculture touching on veterinary. There is no response yet and as far as the issues going on in this County the problem on rabies disease is persistent. A child from Chemagel ward died and is suspected to be due to rabies while some are hospitalized. There should be timelines for Questions and Statements to be answered.

**Hon. Speaker (Hon. Cosmas Korir):** Hon. member I remember you raised that question. You have started debating before giving the answers too. Last week it was directed that the committee Agriculture, Livestock and Fisheries to answer by tomorrow afternoon.

**Hon. D. Kirui (Ndaraweta Ward, UDA):** Hon. Speaker there is a report that our Chairperson Agriculture, Livestock and Fisheries is going to table today. Even the Hon. Member is aware. It is only that he has not presented his side and he is trying to blame us all.

**Hon. W. Kiprotich (Chepchabas Ward, UDA):** Hon. Speaker, I read what Hon. Busienei is talking about and all the Questions and Statements have timelines. It is only that Members do not stick to the timelines. Hon. Speaker, through your chair, I urge the members to be active so that if a question is given a timeline of 7 days it should be 7 days. An answer given after the timeline may not assist.

**Hon. Speaker (Hon. Cosmas Korir):** Even Hon. Busienei did not give his answer as directed. I direct that if I give a directive that you finish within a given period and you fail to do so, the next thing is to loss the position of Chairmanship and given to someone who has capacity. That is the only way we can move forward. I will be strict on timeline.

**Deputy Speaker (Hon. L. Rotich, Chesoen Ward, UDA):** Mr. Speaker, we as the liaison committee have asked the chairpersons in committee to come up with work plan. The questions and statements must feature in the work plan.

**Hon. Speaker (Hon. Cosmas Korir):** There is something you need to do as liaison committee. We came up with the Supplementary Budget and we allocated some money. You have the business of allocating the same funds to different committees. Kindly do that before the end of today. There

are also names of members that appear in Sectoral committees while others are not. There is need for balancing for around 3 or 4 Members.

**Deputy Speaker (Hon. L. Rotich, Chesoen Ward, UDA):** Obligated Mr. Speaker.
