Hon. Speaker (Hon. N. Mutai): Good morning Hon. Members. Welcome to this morning's session. Orders!

APPOINTMENT OF HOUSE BUSINESS COMMITTEE

Hon. Speaker (Hon. N. Mutai): Hon. Davis.

Hon. D. Kipkirui: Hon. Speaker, firstly, I appreciate the House for debating yesterday on the same Motion before us today. It is therefore a resumption of the debate pursuant to the Standing Order 32. The same was interrupted yesterday.

The reason why we have the mentioned names is that the same Members have served this House for the better part of the life of this House. We also use the same to balance the Committees. Once we interfere with this Committee, it will affect the constitution of the other Committees. This means we shall have to go back and form the Committees.

We have only about six months to break for General Elections. Therefore, I request the Members to pass the Motion as it is. It may not be perfect but it is good. This House has run for the last four years using the same Committee.

Hon. Speaker, what happened here yesterday is the same thing that happened in the National Assembly. The Leader of Majority tabled their House Business Committee and was debated and shot down. However, they later rescind their decision.

The importance of this House Business Committee is that we do not have a calendar for the remaining six months and the Committee is supposed to come up with the calendar and approve it.

Hon. Speaker, we are in a campaign mood and we may not be having a lot of time of push and pull. I humbly request that we do not have to take much of our time discussing the composition of the Committee. If we do, then we have to go back and reconstitute the other committees.

Hon. Speaker, before I did this, I consulted the Leader of Minority and I am happy that he is here. I also consulted the Leader of the Majority Party. He is also present in the House. Before I end, I once again plead to the House that we pass this Motion as it is.
