Hon. J. Chepkwony: Thank you, Hon. Speaker, Sir. I beg to Table the Supplementary Budget for the Financial Year 2018/2019 for the County Assembly.

Hon. Speaker (Hon. D. S. Rotich): Proceed to Table.

(Hon. J. Chepkwony laid the Paper)

Hon. Speaker (Hon. D. S. Rotich): Thank you, Hon. Deputy Majority Leader. The Supplementary Budget Papers for the County Executive and the County Assembly that have been laid before the House stands committed to the Committee on Budget and Appropriation. The Committee Report should be Tabled within seven days since it is an urgent issue. Secondly, The Bomet County Public Participation Bill 2018 (Bill No. 11 of 2018) now stands committed to the Committee on Administration, Peace, Justice and Legal Affairs and its Report should be Tabled before the House within the twenty days.

(Hon. L. Kirui rose on a point of order)

Hon. L. Kirui: Mr. Speaker, Sir, considering the urgency and that we are running short of time especially on the Supplementary Budget, I wish to get a clarification from the Chair whether it should be strictly seven days as you have directed or less.

Hon. Speaker (Hon. D. S. Rotich): Hon. L. Kirui, it is within seven days. It is therefore upon the Committee and the Leader of Majority to move a procedural Motion that can speed the process.

(Hon. R. Serbai rose on a point of order)

Hon. R. Serbai: Mr. Speaker, Sir, as far as I do understand, when the Chair directs that within seven days, it can be even a day or two as long as it is within the seven days and not beyond. So, it is upon the Committee to fast track.

Hon. Speaker (Hon. D. S. Rotich): Yes.
