STATEMENTS DUE AS AT TUESDAY 9TH SEPTEMBER 2025

1. Comprehensive statement by Hon. Joseah Samoei from the Chairperson Committee on Energy, Environment, Water and natural resources concerning the construction of Sagenya water project in Nyangores Ward. In the statement, the Chairperson should indicate:

- I. why the project has not been completed despite having been allocated funds in the previous financial years.
- II. The plans that the department have in order to ensure that the project is completed.
- III. Whether the contractor has been paid the full contract amount.

2. Comprehensive statement by Hon. Ernest Rotich from the Chairperson Committee on Health and Sanitation concerning the general status of health facilities in Bomet County. The Hon. Member stated that the same had been necessitated by the recent incidences of loss of

lives in the County health facilities including but not limited to the loss of one Ms. Damaris while giving birth at Cheptalal Sub-county hospital.

In the statement, the Chairperson should indicate:

- I. The circumstances that led to the unfortunate demise of Ms. Damaris while giving birth in Cheptalal sub-county hospital.
- II. Whether the personnel manning the County and Sub-county hospitals ranging from the administrative heads are competent to run the stated facilities.
- III. The Honorable member asked to be provided with the qualifications of each of the administrative head of the County and Sub-County hospitals in the County.
- IV. The adequacy and availability of drugs and medical services in the County and Sub-county hospitals
- V. The referral protocols in the County Referral and Sub-county hospitals including the personnel involved in the referral procedure.
- VI. The facilitation of the personnel serving in the ambulance services and the maintenance of the ambulances serving in the county and sub-county hospitals.
- VII. The expenditure reports of the Department of Medical Services for the month of July 2024 to date.

The CECM Medical and Health Services who was present during the plenary sitting on 28th November 2024 provided preliminary response to the statement. The CECM was directed to provide a comprehensive response in a period of one week.

3. A comprehensive statement sought by Hon. Ernest Rotich, MCA Mogogosiek Ward from the Chairperson Committee on Agriculture, Fisheries and Livestock on the Expenditure of NAVCDP donor funds.

In the statement, the Chairperson should provide:

- I. A detailed and itemized expenditure report for the FY 2022/2023, including a breakdown of the specific projects implemented within each Ward, along with their respective impacts and outcomes.
- II. A comprehensive expenditure report for the FY 2023/2024, outlining the specific projects undertaken in each Ward, with a clear explanation of their objectives, progress and any challenges encountered.

III. A detailed departmental itemized expenditure report for the first nine months (1st July 2024-31st March 2025) of the FY ending 30th June, 2025, including an overview of the ongoing or completed projects in each Ward, and an assessment of the efficiency and effectiveness of the fund utilization during this period.

4. A comprehensive statement from the Chairperson Committee on Roads, Transport and Public Works concerning the rehabilitation of Zero Two steel Foot Bridge in Ndaraweta ward.

In the statement, the Chairperson should:

I. Indicate why despite the award of a contract of KES 3,826,260 for the rehabilitation of the foot bridge, the foot bridge was not rehabilitated to a proper state.

II. Provide an engineer's report on the workmanship that was done on the footbridge vis-à-vis the contract amount used;

III. Explain why the contract was signed just four (4) days after the notification to the successful bidder contrary to section 135(3) of the Public Procurement and Asset Disposal Act, 2015 which requires that at least a period of 14 days should have elapsed following the giving of that notification provided that a contract shall be signed within the tender validity period.

The Committee was directed to respond in seven (7) days period.

The statement was responded to on 07-05-2025 09.30 A.M but the response was unsatisfactory, the Assembly resolved that the Assembly invites the County Executive Committee Member (CECM) for Roads, Public Works and Transport. CECM is due to appear Wednesday 14-05-2025.
