7. QUESTIONS AND STATEMENTS DUE ON 28/11/2023 AT 2.30 P.M.

- 1. Question raised by <u>Hon. Joseah Samoei on 14th November 2023</u> regarding the Nyangores Ward Office which has not been completed. Specifically, the Hon. Member sought answers to the following;
 - a) Why has the project stalled for over 10 years?
 - b) Whether the contractor has been paid for the construction work?
 - c) What plans do the relevant departments have concerning the completion of the project?

The Hon Speaker had directed the committee to give a report of all stalled ward offices across the county.

[Committee on Administration, Legal Affairs and Citizen Engagement]

The response issued on the above statement was satisfactory. However, The Deputy Speaker directed the Chairperson, Administration, Legal Affairs and Citizen Engagement to respond to

the question raised by Hon. Eric Kirui on availability of land in Kimulot Ward. The issue to be responded to on Wednesday Afternoon.

2. Hon. Charles Langat sought the following statement –

Whereas the Standing Orders number 19 expressively defines who a leader of the minority is, equally Article 108 of the Constitution of Kenya 2010 provides that "there shall be a leader of majority party and a leader of the minority party". Being a ranking member in the House, and actively subscribing to the ideals of the UDA party, the Secretary General of my party on March 14th 2023 announced that among the parties that merged with UDA is Chama cha Mashinani.

Under the Political Parties Act, the Registrar of Political Parties gazetted the dissolution of Chama cha Mashinani and transferred their records, assets, liabilities, rights, and obligations to UDA, including their entitlement to the Political Parties Fund under Section 25 of the Act.

It is therefore imperative to know that based on that official pronouncement, members of UDA and members of Chama cha Mashinani belongs to one coalition. Standing Orders number 18 states that the largest party or coalition of parties in the county assembly shall elect a member of the County Assembly belonging to the largest party or coalition of parties to be the leader of the Majority party.

Based on the above stated facts, I wish to be informed of the following;

- 3. What constitutes a minority party numerically?
- 4. Does a party that has only two elected members enjoy equal rights to hold an office shadowing the office of the Majority Leader that has membership of over twenty members?
- 5. Is the office of the Minority Leader in the County Assembly of Bomet still recognized as an established office and if yes, whether there is a substantive office holder of that office?

The Deputy Speaker directed that the Speaker would issue a ruling on Wednesday 6^{th} December, at 2.30 p. m
