Question raised by Hon. Josphat Kipkirui on 14<sup>th</sup> November, 2023 to the Chairperson Committee on Energy, Environment, Water, and Natural Resources concerning the alarming state of the Mogombet Water Project in Bomet Central which serves the residents of Silibwet Township and Singorwet wards. The Hon. Member noted that despite substantial resources being allocated, the project seems to have failed in fulfilling the intended purpose. Specifically, the Hon. Member sought;

- i) To be supplied with a detailed report on the current status of the project

- ii) To know the reason for the apparent inefficiency.
- iii) To know the steps being undertaken to rectify the situation to ensure that residents receive the expected benefits.

The Chairperson of the Committee on Energy, Environment, Water and Natural Resources Hon. Rosaline Cheptoo issued a response to the statement which the seeker termed as having being satisfied with the response. However, the Speaker directed the committee to follow up with the department and update the County Assembly on any new development.
