4. COMMUNICATION FROM THE CHAIR

The Hon. Speaker gave the following Communication:

“Hon. Members, I have received a communication from the Office of the Governor nominating persons who have been sourced and recommended for appointment to hold offices within the County Government as follows;

1. Pursuant to Section 58 (1) (b) of the County Governments Act, 2012 Mr. Justus Kibet Langat nominated as a Member of the County Public Service Board.
2. Pursuant to Section 35 (1) of the County Governments Act, 2012 Ms. Caroline Chebet Kirui nominated to the position County Executive Committee Member for Youth, Gender, Sports and Culture
3. Pursuant to Section 45 (1) (b) of the County Governments Act, 2012 Mr. David Cheruiyot Kikwai nominated to the Position of Chief Officer, Department of Finance

Hon. Members, Pursuant to section 7(1) of the Public Appointments (County Assemblies Approval) Act 2017, I commit the said nominees to the following committees for vetting;

1. Mr. Justus Kibet Langat- Member of the County Public Service Board to the Committee on Labour and Public Service
2. Ms. Caroline Chebet Kirui-County Executive Committee Member for Youth, Gender, Sports and Culture to the Committee on Appointments.
3. Mr. David Cheruiyot Kikwai-Chief Officer, Department of Finance to the Committee on Finance and Economic Planning.

The Committees were given a period of fourteen days to carry out the vetting exercise and table their respective reports in the County Assembly for debate and decision.”

5. **NOTICE OF MOTION**

Hon. Leonard Ngeny gave a notice of the following motion;

THAT, aware that one of the functions devolved under Part 2 of the Fourth Schedule to the Constitution of Kenya 2010 is that of County Planning and development, also further aware that Section 36 of the Urban Areas and Cities Act 2011 provides for the objectives of Integrated Urban Areas and City Development Planning which includes the preparation of a geographic information system for a city or municipality; also aware that the County Executive Committee has not developed any policy on street naming through its board of municipality, also further aware that having a street naming policy based on a set of criteria can prevent conflict and provide a historical context for future generations in our community; this County Assembly urges the County Executive Committee to develop a street naming policy for naming of streets in our towns and municipality.

1. Comprehensive statement sought by Hon. Robert Serbai on 7th March, 2018 from the **Chairperson Committee on Education, Youths and Sports** on the construction of Early Childhood Education (ECD) Centres by the County Government. The Hon. Member wanted to be specifically informed on the following;
 - a) The total funding that the County Government has used in the construction of ECD centres in the Financial Years 2014/2015, 2015/2016 and 2016/2017
 - b) The cost of each ECD centre that was constructed over the said period of time.
 - c) The number of ECD centres per ward that have been constructed and their current status in the above stated financial years.
