- (c) The name of the contractor engaged in the work financed by the County government in the water project.
- (d) The reason as to why the weir which had been scheduled to be constructed has not been completed to date.”

The statement was directed to the Chairperson Committee on Energy ,Environment ,water and Natural Resources who was given a period of 14 days to respond to the statement.
