 3. Whether requisite approvals were sought by the County Executive before the money was borrowed.
 4. Whether the amount borrowed has been fully repaid.

- ii. Comprehensive statement by Hon. Robert Serbai from the Chairperson Committee on Education, Youths and Sports on the construction of Early Childhood Education (ECD) Centres by the County Government. He wished to be specifically informed on the following;
 - 1) The total funding that the County Government has used in the construction of ECD centres in the Financial Years 2014/2015, 2015/2016 and 2016/2017
 - 2) The cost of each ECD centre that was constructed over the said period of time.
 - 3) The number of ECD centres per ward that have been constructed and their current status in the above stated financial years.

The Statement was committed to the Committee on Education, Youths and Sports and it was directed to respond to the statement within 21 days.
