- 1) Comprehensive statement sought by Hon. Weldon Kirui from the Chairperson Committee on Labour and Public Service regarding the office of the County Secretary. In the statement, the chairperson was to respond on the following:
 - a) In the view of the recent judgment issued by the High Court of Kenya at Kisumu nullifying the appointment of Stella Chepkoech Langat as the County Secretary, I seek to be informed by the County Executive Committee Member for Administration, ICT and Public Service on what measures has been taken by the County Executive following her nullification of being the County Secretary?

- b) Whether the County Government has initiated the process of recruiting the County Secretary
- c) Who is the Acting County Secretary?
- d) The County Assembly be furnished with a list of all the appointments and contracts executed by the former County Secretary Ms. Stella Chepkoech Langat from the date of her appointment up to date for purposes of mitigating any potential legal challenges.

- 2) Comprehensive statement sought by Hon. Augustine Koske from the Chairperson Committee Labour and Social Services. The Hon. Members sought;
 - a. To be furnished with a comprehensive report by the County Public Service Board on the recruitments conducted by the it from 1st January, 2020 to date.
 - b. The report including the list of all the applicants, shortlisted candidates and eventually those who got employed and the positions they hold. Further the report should indicate the position applied for, their sub counties and wards.
 - c. The report should further demonstrate whether the requirements of section 65 of the County Government Act, 2012 were met.
 - d. The expenditure report of the County Public Service Board from 1st January, 2020 to date.
 - e. The list of the panelists conducting the interviews.
