5. STATEMENTS

The following statements were sought by Hon. Zadock Kilel;

- 1) Comprehensive statement from the Chairperson Committee on Energy, Environment, Water and Natural Resources concerning water projects within Merigi Ward. In the statement, the chairperson should:
 1. State the reason why pipes were laid from Bondet to Bukacha and Bondet to Menet yet water has not been supplied to benefit the residents.
 2. State the reason why water tank at Bondet has not been completed to date
 3. State the reason why construction of Kiromwok Dispensary Water Tank, Bukacha Water Tank and Menet Primary Water Tank has not commenced yet it was scheduled to be done three years ago.

4. State when the water projects in the ward will be completed considering that Kiromwok and Menet sub-locations were to benefit.

The Hon. Speaker directed the Committee on Energy, Environment, Water and Natural Resources to deal and issue a response within 21 days.

2) Comprehensive statement from the Chairperson Committee on Infrastructure (Roads, Transport and Public Works) concerning the status of Belgut-Molem road within Merigi Ward. In the statement, the chairperson should: -

- i. Explain the reason why murraming, construction of Culverts and compacting of the said road was not done despite the grading having been done eight months earlier.
- ii. Indicate when the County Government intends to complete the construction of the said road.

The Hon. Speaker directed the Committee on Infrastructure (Roads, Transport and Public Works) to deal and issue a response within 21 days.
